Is there a limit to the number of documents that Verifyle will hold?

You can have 1500 workspaces and you can take up 250 gigabytes of space.

Import your contact into Verifyle and then start your workspaces. You can do an export and import by backing up your contacts intro a CSV file and then upload the CSV file into Verifyle. You can accomplish this in less than 5 minutes!

The documents listed on the right side are already in the folder(workspace) that you established. You can move a document from folder to folder by clicking on the gear, select send to and in the thread you will see a drop down menu and then select which folder that you want the document to appear in.

Rick was a wet signature. Some of the software packages will place your name in the signature area and that is considered a digital signature that is acceptable.
